Justice for All

Laura Ramos James fights with compassion.

An indigent mother of two was eight months pregnant when a high-speed vehicle collided with her car. The mother survived, but the baby, having suffered traumatic injuries, died a few days after birth. Personal injury attorney Laura Ramos James championed the bereft mother's cause and won her a \$2.75 million settlement.

"Money will never heal a parent's grief, nothing will, but in this case, it allowed a mother to provide a better life for her two sons—all in her baby girl's memory," says James, founder of Ramos James Law.

Stories like these compel James to show up for work each day. No case is too big or too small for her firm, which is dedicated to delivering concierge-style legal services without discrimination.

Equipped With Empathy

As a personal injury victim herself, having survived a dog attack as a toddler growing up in Mexico, James understands her clients' trauma firsthand. She knows how it feels to be wronged by another's negligence, and she fights to ensure her clients feel seen, heard, and defended against injustice.

"As a new mother, my work has taken an even deeper meaning. I don't want my daughter exposed to negligent drivers on the road," James says. "By holding individuals and companies accountable, we're not just defending those who have been wronged, but also protecting our families from future injustices."

With extensive experience in trucking cases, commercial accidents, and drunk driving accidents, James puts a high priority on approachability. "We avoid

'legalese.' We explain things in simple, digestible terms so clients have a clear understanding of the strategy we choose for their case and the routes available to them. That's because we take pride in providing top-notch legal services to people from all walks of life."

From the get-go, clients get transparent timelines, have clarity about each step, and receive ongoing communication. "Most cases in litigation take some time, but our clients don't get lost in the system," James says.

Everyone Matters

James recognizes the heavy load her own team carries when they meet clients in stressful circumstances. As such, she prioritizes her employees' well-being with a generous benefits system as well as flexible and hybrid work schedules, offered long before the pandemic.
